

Compare old Xero plans with new

A guide for Xero partners to the new plans for the UK

Simpler choices, more inclusions

Xero's new plans are designed to provide small businesses with easier access to the tools to help run their business efficiently, make it simpler for you to recommend the right plan, and tailor your practice services to clients. The new plans are available from 12 September 2024.

What's new

Xero has simplified its partner plans (retaining Xero Ledger and Xero Cashbook), launched three new streamlined business plans (Xero Ignite, Xero Grow and Xero Comprehensive), and enhanced the Ultimate plan in the UK. That means easier access to tools, more bundled features, and fewer plans and add-ons to navigate.

From 12 September 2024, the new plans replaced VAT Cashbook, Starter, Standard and Premium plans, which are no longer sold; existing add-ons will be simplified; and any new clients need to be added to a new plan.

Enhancements to Ultimate plans, which include Xero Expenses and Xero Projects for up to ten people instead of the current five and up to 15 bill payments (GBP) per month, + £0.20 per additional bill payment (excludes VAT) also began from 12 September.

Phased move to new plans

- Enhancements to the Ultimate plan took effect on 12 September
- For all other plans, Xero will move subscribers who
 haven't already moved to a new plan in phases, taking
 into account their current plan and add-ons. For the
 majority of customers, this means more features for the
 same or lower price when they move to a new plan
- You can choose to move clients you hold the subscriptions for to new plans before we move them
- If you want to upgrade or downgrade a plan, or add or remove an add-on from a client's plan, you'll need to choose one of the new plans; if you transfer a subscription, the new subscriber will need to choose one of the new plans.
- If a subscriber has the payroll, expenses or projects add-on attached to their current plan and needs to add additional users, they can do so and remain on the old plan (until Xero moves them); overage charges continue to apply.

- Once you or your clients have moved to a new plan, the previous plan will no longer be available
- With add-ons becoming bundled into certain plans, your partner points or partner program status may be impacted when a plan is moved
- We'll ensure that you have a minimum of 60 days' notice before the plans you hold the subscription/s for are moved, including information about the plans we intend to move your subscription/s to.

- Xero Ultimate: Accounting, payroll and forecasting tools to help businesses scale for future growth

- Limits for Xero Projects and Xero Expenses are per active user, per month.
