

# NZ Roadshows 2024 - Terms and Conditions

Welcome to the 2024 NZ Roadshows. Your registration includes entry for one (1) attendee to:

- Dunedin Town Hall in Dunedin on 29 July 2024; or
- Christchurch Town Hall in Christchurch on 31 July 2024; or
- Claudelands Convention Centre in Hamilton on 1 August 2024; or
- Shed 6 in Wellington on 6 August 2024; or
- Palmy Conference + Function Centre in Palmerston North on 8 August 2024; or
- Viaduct Events Centre in Auckland on 12 August 2024, (each an **Event**).

#### ATTENDANCE TERMS AND CONDITIONS

- 1. These terms will apply to everyone who attends the Event. By attending, you acknowledge and accept these terms in full.
- 2. Xero reserves the right to reject or accept your registration at any time in its absolute discretion. Acceptance of your registration is confirmed by Xero only when the acceptance is communicated to you by email.
- 3. You agree to comply with all reasonable instructions issued by Xero or venue management in relation to the Event.
- 4. You acknowledge that the material presented at the Event is subject to copyright and cannot be re-used without the express written permission of Xero.
- 5. All unauthorised photography and the recording or transmitting of audio or visual material, data or information by you at the Event is expressly prohibited.
- 6. During the Event, employees and/or representatives of Xero may be taking photographs and audio and visual recordings of the Event. Such photography and audio and visual recordings may include images and/or recordings of you, including any interview with you at the Event. # NZ - Scavenger Hunt

      - ii) NZ: Physical Using the cubes from 2023 with post it notes



- 2) Once complete, the Eligible Entrant must go to the registration desk to show the Xero staff member the completion page to then have their delegate badge scanned.
- 5. The Roadshow Competition has a limit of one entry per Eligible Entrant for all Events.
- 6.
